# Alpha Academy Charter School Opt-Out Policy

# 1. Introduction

Alpha Academy Charter School is dedicated to providing a comprehensive and inclusive educational experience for all students. Recognizing that parents and guardians may have preferences regarding their child's participation in certain school activities, programs, or curricula, this opt-out policy outlines the procedures and guidelines for parents to formally request their child's exclusion from specific school activities.

### 2. Purpose

The purpose of this policy is to:

- Respect parental rights and choices regarding their child's education.
- Provide clear guidelines for parents and guardians to opt their child out of specific activities or programs.

# 6. Procedure for Opting Out
