

Alpha Academy Charter School Responsible Use Policy for IT Equipment

Introduction

Alpha Academy Charter School is committed to providing a supportive and safe learning environment. Our use of technology is integral to achieving our educational goals. This Responsible Use Policy (RUP) outlines the guidelines and expectations for the appropriate use of Information Technology (IT) equipment by students, staff, and faculty. Adhering to these guidelines ensures that all users can benefit from technology in a safe, respectful, and academically focused environment.

Purpose

The purpose of this policy is to ensure that IT equipment is used responsibly, ethically, and legally. This policy applies to all IT equipment owned, leased, or used by Alpha Academy, including but not limited to computers, tablets, smartphones, networks, software, and other electronic devices.

Scope

This policy applies to all students, staff, and faculty at Alpha Academy Charter School. It encompasses the use of IT equipment both on and off school premises, during school hours, and at school-sponsored events.

General Guidelines

1. **Respectful Use:** All users must treat IT equipment with care and respect. Damaging or defacing equipment, engaging in unauthorized repairs, or using equipment in a manner that disrupts others is prohibited.
2. **Appropriate Content:** Users must ensure that all content accessed, shared, or created using school IT equipment is appropriate for the educational environment. Obscene, offensive, or discriminatory material is strictly prohibited.
